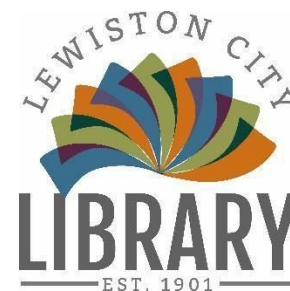


Lewiston City Library – Board of Trustees Regular Meeting - Amended 2/11/2021 AGENDA
