<b>BUSINESS PREMISES INSPECTION FEE</b>			
\$219.00 (New Applications*)			
*An inspection fee may be required, determined by the Building Official, for the following type of businesses, but not limited to: Adult/child care facilities, alcohol establishments, assembly, automotive/truck repair facilities, barber/beauty shops, food or beverage establishments, grocery/convenience stores, gasoline stations. A change of use or occupancy will also require an inspection through the Building Department Permit Center. Other circumstances of the business premises, not determined at the time of application submittal, may require an inspection with the inspection fee due prior to the continuation of the review process of the application for license.
